Subsequent payments are due by April 31st of the specified year. All gifts unless otherwise designated will go to the **School of Law-Class of 2010 Endowed Scholarship** (Minimum of \$50,000 must be raised to establish an endowed fund. If the **School of Law - Class 2010 Endowed Scholarship** fund does not reach \$50,000 by the end of the pledge period it may be applied to current use scholarships).
